# Inter-American Commission of Women (CIM)

The CIM/OAS is the main political forum in the region for the recognition of the human rights of women and gender equality. Since its creation in 1928, the CIM has played a prominent and strategic role in the promotion of women's rights in the hemisphere.



**Regional multilateral body** that assembles Ministers and high-level authorities on gender equality in the Americas.



Has secured **Inter-American conventions** on nationality and civil and political rights of women.



**Advises and supports States** in the design and implementation of national instruments and public policies to promote women's rights.



Has promoted the **Belém do Pará Convention**, the most important international treaty for the prevention and eradication of violence against women, ratified by 32 Member States of the OAS.



The **MESECVI** analyzes the progress in the implementation of the **Belém do Pará Convention**, issues recommendations and generates standards on the right of women and girls to live free from violence.



From an **intersectional perspective**, the CIM raises the voices and responds to the agenda of women in all their diversity.

#### **Political rights and democracy:**

Promote parity and women's political leadership.

#### **Economic rights for integral development:**

Strengthen the legal framework and value women's unpaid work.

#### Women's right to live free from violence:

Prevention and punishment of all forms of violence, follow-up of the implementation of the Belém do Pará Convention in States Party.




#### Mainstreaming the gender perspective:
