CHANGE OF DATE OF THE SECOND MEETING OF MINISTERS AND HIGH-LEVEL AUTHORITIES ON SUSTAINABLE DEVELOPMENT WITHIN FRAMEWORK OF CIDI

(Approved during the meeting held on October 4, 2010)

THE PERMANENT EXECUTIVE COMMITTEE OF THE INTER-AMERICAN COUNCIL FOR INTEGRAL DEVELOPMENT (CEPCIDI),

#### HAVING SEEN:

Resolutions CIDI/RES. 187 (XI-O/06), AG/RES. 2211 (XXXVI-O/06), "First Inter-American Meeting of Ministers and High-Level Authorities on Sustainable Development within the Framework of CIDI," CIDI/RES.199 (XII-O/07) and AG/RES. 2312 (XXXVII-O/07), "Report of the First Inter-American Meeting of Ministers and High-Level Authorities on Sustainable Development within the Framework of CIDI"; CIDI/RES. 236 (XV-O/10) and AG/RES. 2572 (XL-O/10), "Second Inter-American Meeting of Ministers and High-Level Authorities on Sustainable Development within the Framework of CIDI"; and

CEPCIDI/RES. 162 (CLV-O/10), "Convocation of the Second Meeting of Ministers and High-Level Authorities on Sustainable Development";

### **CONSIDERING:**

That the Heads of State and Government of the Americas, at the Fifth Summit of the Americas, called for the ministers and authorities responsible for sustainable development to meet in 2010, under the auspices of the OAS;

### TAKING INTO ACCOUNT:

That it is incumbent upon the Inter-American Council for Integral Development (CIDI), in the framework of the 2006-2009 Strategic Plan for Cooperation for Integral Development, to foster dialogue on sustainable development and the environment as one of its priorities;

That two preparatory meetings for the ministerial meeting have been held: in July 2010, at OAS headquarters in Washington, D.C., and September 2010, in Mexico City, Mexico, where the delegations had an opportunity to engage in enriching and productive dialogue in this area and made significant progress with the negotiations for the Draft Declaration of Santo Domingo for the Sustainable Development of the Americas; and

The results of the virtual forum and consultations with civil society and other social actors that took place in Saint Lucia, Argentina, Costa Rica, and Dominican Republic, as well as the consultations with the private sector; and

HAVING SEEN the note from the Permanent Mission of the Dominican Republic which, in response to the concerns of several delegations about the preparatory meetings and rounds of negotiation for the XVI Conference of the Parties (COP16) to the United Nations Framework Convention on Climate Change (UNFCCC), proposes changing the dates of the Second Meeting of Ministers and High Authorities of Sustainable Development within the Framework of CIDI, to be held in Santo Domingo, to November 17, 18, 19, 2010 (CEPCIDI/INF.100/10),

#### RESOLVES:

- 1. To endorse the change of dates proposed by the Government of the Dominican Republic and to postpone the holding in Santo Domingo of Second Meeting of Ministers and High-Level Authorities on Sustainable Development, until November 17 to 19, 2010.
- 2. To call upon the member states to participate in the Second Inter-American Meeting of Ministers and High-Level Authorities on Sustainable Development within the Framework of CIDI by sending their highest authorities on sustainable development.
- 3. To instruct the General Secretariat to support, through the Department of Sustainable Development of the Executive Secretariat for Integral Development (SEDI), the preparation and organization of the ministerial meeting and to report to the Permanent Executive Committee of CIDI (CEPCIDI) on its outcome.
